JOURNAL DESCRIPTION AND MISSION

Research in Gerontological Nursing is a forum for disseminating peer-reviewed, interdisciplinary, cutting-edge gerontological nursing research to investigators, educators, academicians, clinicians, and policymakers involved with older adults in all health care settings. The Journal accepts manuscripts reporting quantitative, qualitative, methodological, philosophical, and theoretical research, meta-analyses, integrative and systematic reviews, and instrument development, with the aims of improving the wellness and quality of care of the older adult population. The Journal adheres to the Uniform Requirements for Manuscripts Submitted to Biomedical Journals (2010) of the International Committee of Medical Journal Editors.

MANUSCRIPT TYPES AND REQUIREMENTS

Original manuscripts should be no more than 18 double-spaced pages in length, exclusive of references, figures, and tables, for original research articles (quantitative, translational/implementation, integrative/systematic reviews, theory, instrument development), and no more than 20 double-spaced pages, exclusive of references, figures, and tables, for qualitative reports.

In addition to original research articles, the Journal publishes the following sections: Research Briefs, Methodological Corner, and Featured Pilot Studies. Research Briefs are reports of small-scale studies (e.g., pilot work, research conducted in one setting, case studies) that may serve to either stimulate further investigation or alert other investigators of work in progress. Featured Pilot Studies are selected by the Editor from applicable Research Briefs. Articles submitted to Methodological Corner describe challenges and solutions to conducting and/or analyzing gerontological research. These include but are not limited to general research issues (e.g., recruitment and retention of older research participants) and topics focused on more specific populations (e.g., obtaining consent from older adults with cognitive impairment). Descriptions of innovative design and analytic approaches are also welcome. Authors who wish to submit manuscripts to a section should indicate which section in their cover letter. All sections should be 8 to 10 pages in length, exclusive of references, figures, and tables.

All manuscripts must include an APA-style abstract of approximately 150 words with a focus on findings and conclusions.

MANUSCRIPT SUBMISSION

BEFORE submission, authors must ensure:

1. The manuscript conforms to the guidelines for manuscript preparation of the *Publication Manual of the American Psychological Association*, 6th ed. (2010).
2. All author identification (such as author names, university affiliations) have been removed from all manuscript files to facilitate blind peer review. "XXX" may be used as a place holder, if necessary.
3. Reports of studies involving human subjects must indicate procedures for the protection of their rights, as well as IRB approval.
4. Published, submitted, or in press articles by the author(s) on the same topic are disclosed to assure no potential duplication.
5. All manuscript pages are numbered.
6. All manuscript files have been checked for spelling errors.

If academic, hospital, organizational, or institutional affiliations are mentioned in the manuscript, it is the responsibility of the author(s) to obtain written permission from the proper authorities (e.g., dean, director) to use the names of such. If applicable, authors should describe the

role of the study sponsor, if any, in study design; collection, analysis, and interpretation of data; writing the report; and the decision to submit the report for publication. If the supporting source had no such involvement, the authors should so state. If applicable, authors must declare whether they had assistance with study design, data collection, data analysis, or manuscript preparation. If the manuscript reports on a registered clinical trial and has been assigned a trial registration number from a public trials registry, please provide this information.

COPYRIGHT AND PERMISSIONS

Articles are accepted for consideration with the understanding that they are submitted solely to *Research in Gerontological Nursing* and have not been published previously. Authors must inform SLACK Incorporated if tables, photos, or illustrations have been previously published. Material reprinted from other publications (including electronic media) must be accompanied by a letter of permission from the publisher, which extends non-exclusive worldwide rights to reprint the material for all forms of media now or hereafter developed to SLACK Incorporated.

Before any manuscript can be considered for publication, the Author Statement must be completed in full, signed, and dated by each author. The Author Statement can be found in PDF format online at <http://www.geronuseresearch.com/about.asp>.

PEER REVIEW

Research in Gerontological Nursing is a juried publication employing the blind peer review system. All submissions will be evaluated using the following criteria:

1. The importance and relevance of the topic to gerontological nursing care; the generalizability of the ideas/research findings.
2. Readability; concise, logical ordering of ideas.
3. Sound rationale for ideas, including background.
4. Adequate documentation of ideas; citation of recent and relevant literature.
5. Appropriateness of inquiry methods, including design, sample, instruments, and procedures, if research.
6. Accuracy of content; soundness of conclusions.

Following unbiased review by the Editorial Advisory Board, Review Panel, and Editor, authors will be notified by e-mail of the manuscript decision. It is recommended that novice authors have their manuscripts reviewed by their well-published peers, instructors, or mentors prior to submission.

Upon publication, the Journal reserves the right to edit manuscripts, delete extraneous or excess material, and change or add titles and headings. It is not Journal policy to provide monetary compensation for articles. Complimentary copies of the journal issue in which a published article appears will be mailed to the corresponding author.

LETTERS TO THE EDITOR

The Journal accepts letters to the Editor about previously published articles or other topics relevant to gerontological nursing practice. Letters should be no longer than 500 words, including references, if any. All letters should contain a clear message or point for readers. Letters may be edited for clarity or length, and may be submitted to the article author for a response. Letter authors must disclose any competing or conflicting interests, if applicable.
